



Dear Parents,

Upland Country Day School will begin the second session of After School Care (ASC) on Monday, January 2nd. ASC is located in the Technology Center and runs from 12:00 to 6:00 pm. Care will be available to students who have registered for the program. ASC is contracted and prepaid seasonally at the rate of \$8.00 per hour. Pre-registration allows us to plan and staff the program appropriately.

Due to safety, program and staffing issues, we must limit the amount of “Drop In” students we accommodate. Upland would like to help families who need emergency or last minute care. In order to do this without compromising the safety of other students it is imperative that we know how many students we will be responsible for at any given time. “Drop In” students will be categorized and charged in one of two ways: a “Drop In” student whose parent or guardian has provided the school with at least 24 hour notice for the need of ASC will be charged a rate of \$9.00 per hour; a “Drop In” student whose parent or guardian has *not* provided the school with 24 hour notice for the need of ASC will be charged a rate of \$13.00 per hour. All students should be picked up from the Technology Center. When picking up your child, please be sure to check in with the ASC provider so that she may accurately track dismissal times. ASC promptly closes at 6:00 pm. A late fee of \$1.00 per minute (per child) will be charged for students who remain past their registered pick up time.
